Privacy Policy

How We Use Your Information

This is the privacy policy of The Tricking Tap Ltd, which is a limited company registered in England.

This policy tells you what to expect when we collect personal information.

The General Data Protection Regulations (GDPR) is effective from 25th May 2018. It requires us to provide detailed information about processing of personal data that can directly or indirectly identify a living person.

Personal data is any information about you that enables you to be identified. Personal data covers obvious information such as name and contact details as well as less obvious information such as identification numbers, electronic location data, images and other online identifiers.

What Personal Data Do We collect

How Do We Use Your Personal Data?

Under the GDPR, we must always have a lawful basis for using your personal data. This is because you have given consent for us to use your personal data, or because it is in our legitimate business interest to use it for your benefit. Your personal data may be used for one of the following purposes:

- Communicating with you
- Supplying our services to you
- Supplying you with information and /or marketing material by email and/or post that you have opted in to. You can unsubscribe or opt out at any time.

How Long Will We Keep Your Personal Data?

The data that we collect will only be stored within England and the European Economic Area (the EEA)

Your Rights

- the right to data portability;
- the right to object; and
- the right to not be subject to automated decision-making including profiling;
- the right to lodge a complaint with the Information Commissioner's Office.
